**999/03/19 Matters arising**

The Chairman reported he had missed the deadline for advertising the vacancy of the new Parish Clerk. The Post was to be advertised in the Hornsea Community News on 18<sup>th</sup> March with a new closing date for applications of 18<sup>th</sup> April. The church wall was discussed, clarity of what Atwick Parish Council is responsible for needs to be looked into and logged. The chairman was aware of the front wall requiring pointing and that would be addressed later in the summer.

It was agreed Mr Kershaw be informed that he has been awarded the 2019 grass-cutting contract. The only difference being is that the invoice needs to show the date of each cut.

It was agreed to proceed with the purchase and fitting of the North Road Sign Proposed by Cllr P Moffatt and seconded by Cllr S Fawcett.
