New benches – wood bench has been delivered and is currently being stored at Village Hall, will be put in place spring 2022

Christmas lights- electric has been tested by Mr Andreson and repairs required done, certificate will be produced, question over working lights and where they are, it was proposed to purchase 6 new light sets. Proposed Cllr McGinnis seconded Cllr Norman

Annie Plant Hire offered to source a cherry picker and agreed to remove all lights Saturday to check and put back up on Sunday, they thanked for their very kind offer.

Church Yard -stump in wall, research into boundary Cllr Norman reported brick wall belongs church, stone wall Parish Council. When diocese agree, and boundary agreed Cllr McGinnis proposed that the council get on with the work Seconded Cllr Moffatt. Ward Cllr Whittle added that this matter had been on the agenda for some time and the council should move forward, all agreed.
